- **Rules changed from 19 May 2022** ([关于自英国赴中国人员申请健康码最新规定的通知 \(china-embassy.gov.cn\)](#))
 - **No need for:**
 - 7-day test
 - antibody (including N protein) test regardless of vaccine status or types
 - X-ray or CT regardless of Covid-19 history
 - **Need to do:**
 - **2 PCRs with 48hours of departure, one of which needs to be within 12hrs of departure – or within 24hrs of departure + 1 LFT (rapid antigen) within 12hrs of departure**



- **In practice**
 - a) **Dual PCRs within 24hrs of departure + 1 LFT within 12hrs of departure: *Flight time 00:00 – 18:00***
 - b) **Dual PCRs within 12hrs of departure: *Flight time 18:01 – 23:59***
 - c) **Some variations**
 - **1 PCR within 48hrs + 1 PCR within 24hrs + 1 LFT within 12hrs**
 - **1 PCR within 48hrs + 1 PCR with 12hrs**
- ✓ *In-clinic tests by a provider approved by the Chinese Embassy in UK: [P020220519229297648161.pdf \(china-embassy.gov.cn\)](https://china-embassy.gov.cn/p020220519229297648161.pdf)*
- ✓ *Different labs or different methods at one lab*
- ✓ *No requirement of lab ISO certificate*
